



FEE FOR SERVICES FOR STARTING POINT REHABILITATION (As of February 2020)

3 Day FCE

Total time = up to 19 hours per FCE.

FCE: Client contact time over a 3-day period (approximately 13 hours).

Report: Medical records review. Report preparation: this includes findings, opinions, conclusions, recommendations, and comments regarding client's occupational future and aspects of future cost of care. (approximately 6 hours report preparation). This is a flat rate. Additional fees may apply in cases of extensive medical records review. See below.

- **Physical Limitations Only:**
Cost: \$175 (hourly rate) X 19 hours = \$3,325
- **With Cognitive Testing:** (i.e. post-concussive syndrome, fibromyalgia, MTBI, etc)
Cost: \$175 (hourly rate) X 20 hours = \$3,500

Re-evaluations, 1 or 2 day FCE's

Cost: \$225 (hourly rate)

Includes evaluation time (2-6 hours) and report time (3-6 hours). Charges are assessed per total hours logged.

FCE Late Cancellation Fees

\$600 if FCE cancellation is less than 5 working days prior to scheduled evaluation date.

\$1200 if FCE cancellation is less than 2 working days prior to scheduled evaluation date.

Late cancellation fees apply in the event of illness, unforeseen circumstances or No Shows.

A late cancellation fee will NOT be assessed if the slot is filled by another client.

All attempts are made to fill slots that are vacated.

Additional Medical Records Review, Report time, or Evaluation Time:

Cost: \$225/hour

Extensive medical records review or additional specialized testing including: job site evaluations, home evaluations, etc.

Report Services/Rebuttals

Cost: \$225/hour

Includes reviewing and commenting on Functional Capacity Evaluations, Job Site Evaluations, Medical Reports, etc.

Rush Report Fee

Cost: \$300.00

If report must be completed before 15 business days following last day of the evaluation.

This cost will be added to the evaluation invoice as an extra fee.

Expert Witness Services

- **\$425/hour for Testimony.** (2 hour minimum). Trials will be billed after the trial is completed.
- **\$225/hour Trial Preparation:** phone calls, report and medical records review, etc.
- **\$150 per hour round trip Travel Time**
- **\$425 Late Cancellation Fee** will be assessed if the cancellation is received within less than 5 calendar days prior to the **Trial**
- **\$600 Late Cancellation Fee** will be assessed if the cancellation is received within less than 2 calendar days prior to the **Trial**.

- For all Expert Witness Services, an **18% late fee** will be assessed if paid after 30 days of the invoice and every 30 days thereafter.

Additional charges which could be incurred include lodging and travel expenses (food, gas, tips, consierge, etc.)

Representing Counsel (or Attorney's representing law firm) must have a signed Agreement on file prior to commencement of their clients' Functional Capacity Evaluation date.

Invoices for all FCE services including the FCE Report will be emailed to the Attorney on file.
